Moldova - key figures

- Area 33.8 thou. km²
- Population 2.513 mil.
- GDP- 16.54 bill. Euro
- Energy consumption 2.77 mill. toe
- Approx. 80% of energy resources imported





Importance of energy efficiency in Moldova

- Energy efficiency is a major focus for the Moldovan Gov.
- Moldova imports approximately 80% of its energy resources (both primary and final energy consumption) as per 2022 statistics
- Adoption of Law No. 139/2018 on Energy Efficiency
- Incorporates Directive 2012/27/EU on energy efficiency and Directive 2018/2002 amending Directive 2012/27/EU
- Commitment to sustainable development principles and efficient energy use in all economic sectors





Law on Energy Efficiency - main provisions and key elements

- Capacity building of the public authority responsible for implementing of EE & RES policy
- The exemplary role of the buildings owned by public bodies
- Compulsory energy audit for large enterprises
- Obligation scheme in field of energy efficiency
- Capacity building of the local energy managers
- Strengthening the local energy services market
- Energy efficiency in public procurements
- National Information System in the field of Energy Efficiency
- Public awareness on the energy efficiency importance








Exemplary role of public buildings 1st attempt (1/3)

GD No. 372/ 2020 Program for the renovation of the central government owned and occupied buildings 2020-2022

Total number of identified buildings 215 units

- Total floor area 426,056 m²
- 1% obligation /2019-2020/ 8.521 m²








Exemplary role of public buildings 1st attempt (2/3)

Two buildings were selected:

- Building no. 1 Chisinau, str. Mitropolit Gavriil Banulescu-Bodoni, 26
- Building no. 2 Chisinau, str. Constantin Tanase, 9

Exemplary role of public buildings 1st attempt (3/3)

- Rehabilitation of a building with a total area of 2,306 m²
- Investment of approximately 12 million MDL
- Average annual thermal energy savings of about 25,600 kWh (12%)


Update of the buildings' inventory

The result of the inventory exercises carried out by the National Center for Sustainable Development (former Energy Efficiency Agency)

- buildings of State Enterprises (e.g. Teleradio Moldova)
